Vide order read as 1st above 74 candidates selected through Employment Exchange (P&E), Thiruvananthapuram were appointed as Agricultural Officers, purely on temporary basis under rule 9 (a) (I) of KS&SS Rule 1958. Vide letters read as 2nd to 4th paper above Principal Agricultural Officers have reported that some of the candidates have not been reported for joining duty and requested to appoint new officers in that stations.

Considering the request of the Principal Agricultural Officers, the following candidates selected through Employment Exchange (P&E), Thiruvananthapuram are appointed as Agricultural Offices on Rs.39500 – 83000/- purely on a temporary basis under Rule 9(a) (I) of KS&SS Rule 1958 for a period of 179 days or till regular hands join duty whichever is earlier and posted to the Krishi Bhavan mentioned against their names.

The candidates must report for duty before the Principal Agricultural Officers concerned within 5 days on the date of receipt of this order.


